

### Purpose and vision

The Mediterranean's challenges don't stop at borders — and neither should our solutions. This event is designed to explore how coordinated action can multiply impact across the region, through interactive and solution-focused sessions.

Our vision is to build a Mediterranean Community of Practitioners: a living network connecting Interreg programmes, national representatives, the European Commission, and field practitioners. The event provides a space to exchange experiences, generate insights, and shape actionable recommendations to strengthen synergies across Mediterranean Interreg programmes.

The Mediterranean itself stands as a living laboratory for cooperation and reform. In this context, the sessions will also explore how Interreg's evidence can guide a more responsive, effective, and results-oriented Policy. Together, we strive to promote meaningful and lasting collaboration across the region — turning shared challenges into shared opportunities.

- **Veliko Srzic - Associate Professor in Water Resources and Environmental Engineering at Split University**, Croatia, and lead player in the **SWAMrisk** project under the **Interreg Italy Croatia** and dealing with water catchment from surfaces and underground basins. Among its areas of interest: coastal systems including hydrogeology methodological approaches, porous media flow and transport, contaminant transport, environmental engineering, environmental monitoring, stochastic and numerical modelling, analytical frameworks.
- **Daiva Matoniene (tbc) - Multi-Level Governance Platform for Climate (MLGP4Climate)**, Türkiye, in support to the **RESWATER** project under the **Interreg NEXT MED** programme dealing with Non-Conventional, Waters (NCW). She promotes cooperation among national and local authorities, municipalities, NGOs, and academia on climate and energy transition supporting the platform in advancing integrated, multi-level climate and energy policies. Her work focuses on sustainable energy and climate action planning (SECAPs) and resilience building.
- **Nicola Tselikas - Civil hydraulic engineer at the Acquedotto Pugliese (AQP)** in Italy and currently head of the Green Management Area of the Environment and Energy Department, collaborating in projects as **RE-WATER** and **ECO-FLOW** under the **Interreg Italy Greece** programme. He has a long experience in Shared water management and governance with leading roles in Wastewater Treatment Plants Areas in Lecce and Foggia and responsible for the management, operation, and maintenance of more than 200 wastewater treatment plants.
- **Stefano Marino - Environmental Engineer at AQP**, Italy, working within the Environment and Energy Directorate (DIRAM/TERBI). He is engaged in assessments of water availability for Apulian aqueduct sources and studies on climate-change impacts on water resources and serves as Technical Manager for Interreg projects including **AQUA** under the **Interreg IPA-ADRION** and **SA RESILIENCE**, under the **Interreg IPA South Adriatic**
