Introduction

The **Work Package 2 – “Communication activities”** aimed at ensuring a constant promotion and publicity of project objectives, outcomes and results, during whole project duration to public.

In this way **Activity 2.2 – “Publications”** aim at covering different aspects of PEPSEA project: precisely, the second-year publication, aim to provide a definition of the Detailed Contingency Plans, a sort of guidelines for their development and an example of the ones developed in PEPSEA pilot sites.

In order to expose these topics as directly as possible to the targeted audience of the project and in accordance with the first-year strategy, the publication, initially conceived only in **English**, was translated also in **Italian** and **Croatian** language.

Regarding the **distribution of the publication**, it has been decided to use two different strategies for each type of publication (printed and digital). **Digital versions** (in Italian, Croatian and English language) were sent by email in a format similar to a "newsletter", with a counter attached to the download link to keep track of the number of clicks (downloads) made. Regarding the **printed version**, instead, it has been decided to proceed with two different strategies, one for Italy and one for Croatia

The dissemination from the n.200 Italian copies was entrusted to **Partner PP6 - Po Delta Veneto Regional Park** while the one for the n.300 Croatian copies was entrusted to **Partner PP2 – ATRAC**.
