INTRODUCTION

The activity 2.4 “Public Events” of WP2-Communication foresees the organisation of Public Events to present project achievements and to engage the key local stakeholders in WATERCARE project. They consist of meetings, ad-hoc seminars, conferences, press releases.

First of all, the target groups have to be identified (citizens, technical experts, local authorities ecc...) and then every event or tool will be addressed to the target group previously identified.

It is very important to put in a visible position the project logo together with a clear reference to the UE co-financing, for example, in the agendas, list of participants, publication and all the promotion materials. 1st PUBLIC EVENT (central-north Italy - Fano): context and results

The first Public Event was held in Fano on the 15th of March 2019 at the premises of PP1 ASET within the framework of INTERREG HR-IT WATERCARE project.

All partners took part in the event in addition to some local authorities, press representatives.

Before the event an agenda was set up in collaboration between each partner, space and equipment were reserved. The attendance list was prepared as well.

Public events are fundamental to introduce the project to local stakeholders and to present the project progresses.

The first public meeting aimed to describe the four-study area: Pescara river, Rasa River, Cetina River, and Neretva River. A detailed presentation was given by PP3, PP8, PP5, and PP6. Governance processes in coastal water management were presented as well by PP2 and PP9.

Institutional representatives such as the Vice-president of the Regional Council of Marche region, the Mayor of Fano Municipality, the president of ASET spa and the Director of CNR-IRBIM participated as well. They took the opportunity to give a brief speech to conclude the first public event.
