OPERATIONS OF STRATEGIC IMPORTANCE (OSIs)

As defined in **EU Regulation 2021/1060 (Art. 2, c5)**, OSIs are operations that make a significant contribution to the **achievement of Programme's objectives** and are subject to special monitoring and reporting measures. OSIs are also critical because of their ability to **bring together different expertise** toward the common goal of improving the cross-border area.

OSIs are thus new types of projects, born with the current **21-27 Programming period**, financed by the European Union through the **Interreg Programs**; their activity aims, through **networking**, to tell their **results and impacts in the community**.





APPENDIX 3 INTERREG VI A IT-HR PROGRAMME

The foreseen categories of OSIs are the following:

- 1) **SMEs Facility**. The aim of this instrument is to target specific domains of the Blue Economy with a high potential in terms of growth, innovation and reinforcement of skills based on CB business cooperation between SMEs/start-ups by minimizing the bureaucratic burden upon them.
- 2) Operation(s) of Strategic Importance that could be funded in relation to the topics proposed in the **EUSAIR flagship themes** mentioned for each SO (excluding SO 1.1, 1.4 and ISO1) and, possibly, coordinated with other Interreg Programmes of the Adriatic-Ionian area, in the framework of the embedding process.




